Status of Collective Bargaining for Teaching Faculty

Collective bargaining for Teaching Faculty resumes today (August 14) and continues August 15, 19, and 20. We filed for conciliation with the Ministry of Labour. A conciliator has been appointed to help with negotiations. The following articles have been signed off: I (Purpose), 2 (Recognition and Definition of the Bargaining Unit), 4 (Management Rights), 6 (Dues Deduction), 7 (No Strikeout or Lockout), 9 (Joint Committee), 10 (No Discrimination or Harassment), 12 (Health and Safety), 14 (Academic Freedom), 18 (Official Files), 22 (Intellectual Property) and 24 (Discipline). Today 8 articles were presented to the Employer. The bargaining team consists of Marnie Ham (Engineering and Applied Science) as chief negotiator working with Richard Bartholomew (Science), Maurice DiGuiseppe (Education), Ruth Simpson (Health Sciences), supported by Amanda Warr, Executive Assistant to UOITFA.

Update on Copyright Act

In response to recent amendments to the Copyright Act and victories at the Supreme Court of Canada, the courts have clarified and reaffirmed rights to use and share materials. Bill C-II, which was passed last summer, added new rights for classroom use of material and expanded fair dealing (the right to copy without permission or payment under various circumstances) to include education. Judges deliberating in the court case found where legislation is open to different interpretations and in an educational context, there is no need to ask for permission to make copies or obtain costly licenses in circumstances where fair dealing and other rights would apply.
